

LEED Sample Source Reporting Summary

For use by WDMA members, a LEED Source Reporting Summary is a document (or report) used in LEED certification to verify and summarize where building materials come from and how they meet LEED Materials & Resources (MR) credit requirements. In simple terms, it shows who supplied the materials, where they were sourced, and whether they qualify for LEED points.

The Source Reporting Summary supports LEED credits related to responsible material sourcing, such as Environmental Product Declarations (EPDs), Sourcing of Raw Materials, Material Ingredients, Low-emitting materials (sometimes referenced alongside, and Regional or responsibly extracted materials. It helps the project team prove compliance during the LEED documentation and review process.

As a resource to WDMA members, below is a sample of a summary report and the information required to document a building product for use in LEED certification. This sample only provides the critical information required for most building products and is offered as an example for reference for door, window, and skylight products:
